

Speaker Agreement and Copyright Release

Copyright Release Statement

By entering this Speaker Agreement and Copyright Release (Agreement), Speakers (You) agree to permit TOCICO to record, capture, edit, and/or use the Recording of your presentation.

The following terms are defined in this agreement:

- **Presentation** refers to the in person or virtual delivery of your session and Q&A at a TOCICO event.
- **Recording** refers to any audio, video, or screen capture of that Presentation created by TOCICO.
- **Materials** refers to any slides, handouts, visuals, or supporting documents submitted by the Speaker to TOCICO in relation to their Presentation.

TOCICO shall hold the copyright ownership for any Recording of your Presentation and shall have permission to continue to use the Recording and Materials in the future. Possible uses may include, but are not limited to, archival copies for educational use, inclusion on TOCICO's and affiliates' websites, the creation of online viewing, downloadable, DVD, or other audio/video files, and public dissemination via distribution partners.

TOCICO will own the copyrights for the Recording and Materials, and **You own the original content within the Presentation**. Unless otherwise agreed upon in a separate written Agreement between You and TOCICO, You are free to give the same Presentation elsewhere, and nothing in this Agreement shall prevent You from doing so.

You are prohibited from recording any part of your Presentation without prior written consent from TOCICO. Upon your written request, TOCICO may provide you with a copy of the Recording and grant you a non-exclusive license for limited personal use as follows:

- You may upload up to a 5-minute excerpt (clip), to your social media, personal or professional website. A link to the full Recording is required when sharing any excerpt.
- You may not post the full Recording on any websites or social media platforms, including but not limited to LinkedIn, Facebook, YouTube.
- You may not share the full Recording with third parties or grant others usage rights.



TOCICO may, at its discretion, provide You with a limited-use promotion code to offer select number of your contacts complimentary access to your full Recording as hosted in the TOCICO websites.

You grant TOCICO permission to use your name, likeness, and biographic information to use, promote, or exploit the Recording or any derivative of the Recording, and Materials submitted by You to TOCICO.

You agree that TOCICO may take photographs, screenshots, screen copies, and/or screen recordings of any event (in person or virtual), and use those images or Recordings for purposes consistent with this Agreement.

TOCICO, at its sole discretion, shall determine the acceptability of any Materials that You submit to TOCICO. In addition, TOCICO shall determine whether to publish or not to publish the Recording and/or Materials, either in whole or in part, at its sole discretion.

If You use any other copyrighted work or Material in your Presentation, You have the sole responsibility to identify it as such and will hold TOCICO harmless for any disputes that may arise.

Additionally, You agree to grant TOCICO a non-exclusive royalty-free irrevocable transferable license to use any Materials submitted by You in support of the Recording, in any medium now known or created in the future. TOCICO in turn shall credit You as the author of Materials upon your written request, in the following format: © Your Name Year.

You acknowledge and grant permission to TOCICO and its affiliates to use any Materials that You provide to TOCICO, to utilize in any manner TOCICO sees fit, including but not limited to web, electronic and print use, free of any compensation and/or royalty.

You agree that Materials must be submitted in an acceptable format to TOCICO—such as PowerPoint (.ppt or .pptx), PDF, or high-resolution image files—and accept all other terms and conditions set by TOCICO.

Any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of or relating to this Agreement and transactions contemplated in it shall be governed by and construed in accordance with the laws of the United States and the State of New York.



In furtherance of TOCICO objectives, Recordings of TOCICO conference proceedings are registered with the Library of Congress and will receive an individual ISSN number. The Library of Congress regulations require the elements of this Agreement to be in full force and effect.
